You will not be allowed to change your reserved spot with other vendors unless you get the written permission from event organizer. You are responsible for bringing your own signage & advertising material. Only food vendors are allowed to sell food; no other vendors may sell food. Vendors can distribute free giveaways to visitors except food, snack and beverages (including tea, coffee, cake & ...). Vendors will be responsible for paying Sales Tax on items sold. All business promotions must be done from within the booth and vendors are not permitted to use other area to promote their businesses. Tables are going to be dismantled by the company providing them at 7:00 PM. Your cooperation and compliance are essential in having a fun, full-filling, and a successful festival for all! Weather conditions are beyond the control of the event organizer and Festival take place rain or shine so no refunds or exchanges are offered to vendors.

ACTIVITY: VENDORS FOR THE ANNUAL NOWRUZ FESTIVAL TO BE HELD AT HILTON FAIRFAX (FAIRFAX, VA) ON MARCH 10, 2024, INCLUDING ALL PRE- AND POST-FESTIVAL ACTIVITIES AT SAID LOCATION.

In consideration for being permitted by the IRANEMA .ORG (Iranema) to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have or which may hereafter accrue as a result of my participation in said activity. This release is intended to discharge, in advance, Iranema (its officers, directors, volunteers, employees, and agents) from and against any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of Iranema (its officers, directors, volunteers, employees, and agents).

I understand that the above activity may be of a hazardous nature and/or include physical and/or strenuous exercise or activity, that serious accidents occasionally occur during the above activity; and that participants in the above activity occasionally sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in said activity, and I hereby agree to assume any and all risks of injury or death and to release and hold harmless Iranema (its officers, directors, volunteers, employees, and agents) who through negligence, carelessness, or any other act or omission might otherwise be liable to me. I further understand and agree that this waiver, release, and assumption of risks is to be binding on my heirs and assigns.

I further agree to indemnify and to hold Iranema (its officers, directors, volunteers, employees, and agents) free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of any injury and/or property damage that I may sustain while participating in said activity.

I further agree to indemnify, defend and hold harmless Iranema (its officers, directors, volunteers, employees, and agents) from any and against all claims, suits, causes of action and damages of whatever nature made and liability for the negligent, intentional acts or omissions of Vendor, its agents, employees or officers arising out of or connected in any manner to said activity. In consideration of vending space the adequacy of which is hereby acknowledged, Vendor, for its heirs, assigns, and successors (collectively herein referred to as "Vendor") hereby RELEASES, WAIVES AND FOREVER DISCHARGES Iranema (its officers, directors, volunteers, employees, and agents) from any and every action, cause of action, complaint, demand, administrative charge, legal right, right to compensation, obligation, damages, liability costs, and/other expense (including attorney's fees) that Vendor ever had, has, may have, may be entitled to or hereafter can, shall or may have or may be entitled to or have against Iranema (its officers, directors, volunteers, employees, and agents), whether legal, equitable or administrative, whether known or unknown, upon or by reason of any matter, cause or thing whatsoever, from the beginning of time to the date of the Activity, including without limitation, any which arise directly or indirectly out of, or related in any way, to its use of the vending space. The parties intend this Hold Harmless Agreement, Waiver, Indemnification and Release to Sue to cover any and all such purported claims or rights whether arising under any policies, ordinances, resolutions, procedures, federal, state or local statute, regulation, order or ordinance; all common law and statutory claims, including without limitation, public policy claims, claims for breach of expressed or implied contract; claims for breach of an implied covenant of good faith and fair dealing; tortious interference with contract or prospective economic advantage; all claims for any compensation or any other form of economic loss, liquidated damages and punitive damages, and all claims for costs and attorney's fees. As such, this Hold Harmless Agreement, Waiver, Indemnification, and Release are intended as a general release.
